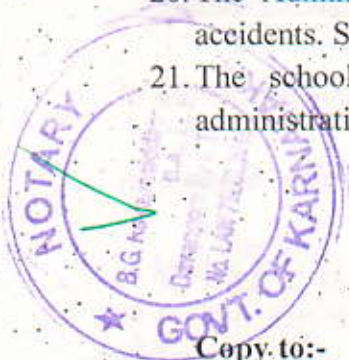
The above mentioned Educational Institution is registered under Sl.no. 01/2011-12 page no. 41, Volume no. 01 and registered in our office education institution register and certified with following conditions.

Conditions :-

1. This Registration Rule will be under 3[5] [4].
2. According to Governing counseling Rule (4) all the conditions should be followed strictly.
3. School's venue area, building, Teaching Aids, Furniture and staff economic amenities etc. should be provided.
4. The institution should not open any additional branches without permission of the Government at any situation.
5. As per permission granted the school should run with particular medium at particular place and there will be no chance of changing.
6. As per the permission granted the administration council, must run the school in the same place and in the same name should not transfer the administration to others without permission of the government.
7. This institution must follow all the rules often as related to the government.



8. As per the Government notification no ED 175 P.M.C 65 Dated: 07/09/1998 and 29/12/1998 is registered permanently unaided. Administrative management has submitted Rs. 50-00 Bond paper and certified with notary.
9. The institution should follow the Karnataka private Education institution rules [Discipline and control] 1999 Rule without fail.
10. The institution should apply the prescribed text book / exam pattern etc. as per the rules of Department and Government.
11. As per the Karnataka Education Act 1983 [Act 1 of 1995] under section 39 and E.D 131 others 98 Bangalore. Dated 04-11-1999. To take permission and provisional approval from government should be submitted within 2 months.
12. As per Government order No ED 28 P.J.C 94 Dated 29/04-1998 from 1-5 standard Kannada Medium or students mother tongue medium of instruction following schools will follow Kannada medium to upgrade from 6th standard. If the institution not follow medium of instruction or else it is noticed Government can take any action or cancel the registration.
13. The institution should deposit security amount in the joint account of D.D.P.I and secretary of the concerned management.
14. As per the sanction, the institution should follow the students, Teachers ratio in each class according to rules.
15. The institution should appoint the qualified and trained teachers according to the department rules.
16. Every year students medical checkup should be done. As per the Karnataka Education Act the institution should provide all the infrastructure like teaching aids, furniture, library books, play ground, school building separate toilets for boys and girls. If it is not provided the recognition may be cancelled.
17. School working hours and days should be followed according to the department.
18. The information regarding the school running. Admission of students academic year should be mentioned / informed to the office. If the school is not running or not following the rules, order will be cancelled automatically.
19. As per the Government notification no E.D 104 SIP 2005 Dated: 12-01-2006 and Government circular no. E.D 208 SEP 2007 Dated: 12-10-2008. The order insists the administrative council has to provide service security for all the staff. If it fails the registration will be cancelled without giving any instructions.
20. The Administrative council will be fully responsible for the disaster or fire accidents. So the administrative council should take care of this matter carefully.
21. The school environment should be neat, good and healthy. The school administrative councils should follow this very strictly.

2. 9. Under the Karnataka Education institution rule of 1995 Government and department prescribed text books should be taught and take measures to see the books will not be burden to children.
10. Under the rule of Karnataka Education institution Dated 04-10-1996 & according to rule 10(04), we should collect only term fees, teaching fees, special development fees. School should paste fees details on the notice board and send the same copy to concerned B.E.O & D.D.P.I office.
11. According to the notification no. ED 39 others 1999 Dated 04-03-2000 Karnataka Education Institution (Regulation of certain fee and donation) rule 1999 should be followed strictly.
12. The institution should deposit security amount in the joint account of D.D.P.I and secretary of the concerned management.
13. As per the sanction, the institution should follow the students, Teachers ratio in each class according to rules.
14. School should appoint B.Ed qualified teachers for the 6 to 8th standard.

19. According to Government circular No ED 27 SEP 03 Date: 13/02/2003 school will follow proper appointment of teacher & maintenance of service book according to rule.
20. Teachers should be appointed for census without fail.
21. If we come to know that, the provided records are fake, then registration will be cancelled at any moment.
22. The strength of the students should not exceed above 50 per each class.
23. Should not change the place or administration up to 5 years of the permission.
24. You should follow the conditions of the Government letter no ED 122; SES 2007 Bangalore Date: 17-05-2007
25. From 1st – 5th standard School should run up in the same medium of instruction in which it has registered earlier.

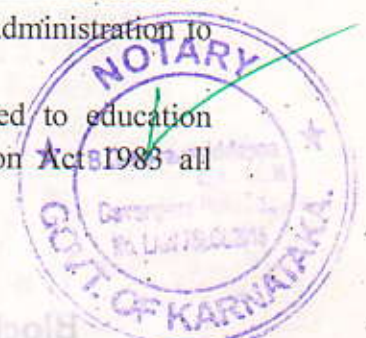

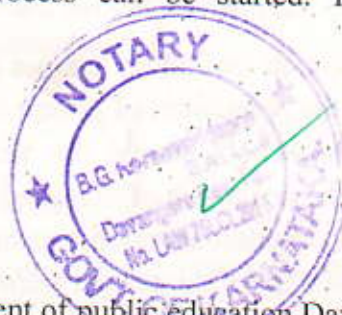
